Policies and Procedures

1. Liability Policies:

- a. Kelsey's Sit, Stay, and Play and its contractors agree to provide services stated in this contract in a reliable and trustworthy manner. In consideration of these services and as an express condition thereof, the client expressly waives any and all claims against Kelsey's Sit, Stay, and Play or its contractors, unless arising from gross negligence on the part of Kelsey's Sit, Stay, and Play. Client agrees to notify Kelsey's Sit, Stay, and Play of any concerns within 24 hours of returning home.
- b. Kelsey's Sit, Stay, and Play cannot be responsible for pets that bite, suffer an accidental death or escape from faulty fencing or from inside the home due to faulty screens, doors, etc.
- c. Kelsey's Sit, Stay, and Play cannot be responsible for any complications pets may suffer or actions of pets while they are unattended.
- d. Kelsey's Sit, Stay, and Play or its contractors shall not be held responsible for the loss, injury, death, or actions of any pet that the client has let outside or has instructed Kelsey's Sit, Stay, and Play to allow outside while sitter is not there. This includes pets with doggie doors and outdoor pets.
- e. The client understands that all pets (where appropriate) must have a veterinarian and must be up to date on the rabies vaccination. Client agrees to reimburse Kelsey's Sit, Stay, and Play for all costs (including, but not limited to, medical care and lost wages) associated with contracting any ailments while exposed to pet(s).
- f. All pets with electronic fences must wear their collars with fresh batteries. Kelsey's Sit, Stay, and Play is not responsible for any animals that get out or inside of perimeter.
- g. Kelsey's Sit, Stay, and Play will sit for acutely ill animals and/or those with uncontrolled medical conditions with the understanding that we are not veterinarians and cannot be held responsible for adverse reactions to medications or therapy instructed by Client. We suggest the pet be boarded with a vet if complications are foreseen.

- h. Kelsey's Sit, Stay, and Play does not accept aggressive animals. Client agrees to be responsible for all costs (including, but not limited to, medical care, attorney fees, etc) if client's pet should bite another person or animal.
 - i. Kelsey's Sit, Stay, and Play will walk unruly or untrained dogs. All pets must be walked on a leash, no exceptions.
 - j. Kelsey's Sit, Stay, and Play does not diagnose, prognosis, or make therapy decisions, nor does it offer veterinary services. Any veterinary/medical concerns will be referred to a veterinarian.
 - k. Client authorizes Kelsey's Sit, Stay, and Play to obtain the services of a locksmith should a key/garage opener malfunction. Client is responsible for all charges if a key was not provided initially by Client.
 - l. Job sharing is not covered under our insurance. We cannot be responsible for your pet or home if another service provider enters your property while we are not there.
2. **Business Hours:** Normal working handler hours are between 7 a.m. and 9 p.m., and office hours are 8 a.m. to 8 p.m. Pet visiting hours fall between the hours of 7 a.m. and will not be scheduled later than 8:30 p.m. Services are usually completed during this time unless we are behind schedule. Kelsey's Sit, Stay, and Play will accept time specific calls but we cannot guarantee specific times accurately. A 30 minute -1 hour window is acceptable.
3. **Convenience Policy:** Requests for services in less than 1 week will incur a \$3 convenience fee; within 24 hrs a \$5 fee; and within 8 hrs a \$10 fee. Kelsey's Sit, Stay, and Play reserves the right to assess each situation individually.
4. **Emergencies:**
 - a. Client agrees to authorize Kelsey's Sit, Stay, and Play to handle any emergencies that may arise. Kelsey's Sit, Stay, and Play will make every effort to contact client, however client gives Kelsey's Sit, Stay, and Play authority to act in the pet's/home's best interest and be available at an hourly rate of \$15.
 - b. Kelsey's Sit, Stay, and Play requires you to have a responsible party to take care of your pet(s) in the event of unforeseen circumstances such as illness and in the event of inclement weather or a natural disaster. It is best your emergency contact is a neighbor so they can reach your home. Kelsey's Sit, Stay, and Play is not responsible for pets once they are received by the emergency contact.
5. **Payment Arrangement:** Payment is expected on the final day(your return) pet sitting services are rendered or on receipt of invoice for daily pet services, such as walks, potty

breaks, etc. The pet sitting payment is gathered in the event of additional unforeseen visits or other costs (such as food, supplies, or vet fees). Payment is expected within 10 business days of the completion or invoicing of daily services or a late charge of \$15 will be applied every 5 business days until, at the very least, payment arrangements have been made.

6. **Cancellation Policy:** Cancellations must be received within 24 hours of scheduled walk/visit or a cancellation fee of \$15 will apply. Cancellation of overnight service must be given with 1 weeks notice or 50% of the fee will be retained. Kelsey's Sit, Stay, and Play reserves the right to deny service or terminate service because of safety concerns, financial concerns, or inappropriate or uncomfortable situations.
7. **Privacy Policy:** Any and all information collected by Kelsey's Sit, Stay, and Play is for our working records only.
